Field Safety Notice - Urgent Medical Device Recall LOTUS™ Edge Valve System

Dear «Users_Name»,

Boston Scientific is implementing a voluntary Field Safety Corrective Action (FSCA) for the recently launched LOTUS™ Edge Valve System to remove all units from the field. The specific list of units is included in this letter.

There have been seven reports where the valve could not be fully locked and released. In six cases, the valve was retrieved and removed, resulting in procedure prolongation. In one case the valve was positioned in the descending aorta. In all seven cases, the patient was successfully treated with a new valve. Boston Scientific has not received any reports of other serious adverse events associated with this failure mode; however potential complications could include stroke and/or vessel trauma.

There is no safety issue for patients who previously received a LOTUS Edge valve since the issue only occurs during the implant procedure and does not impact the performance of the implanted valve.

This FSCA affects all UPNs and batches of the LOTUS Edge Valve System.

Note: The current generation LOTUS Valve System continues to be available and is not affected by this removal.

Our records indicate that your facility received some of the concerned product. The **table below provides a complete list of all affected products**, including Product Description, Material Number (UPN) and Lot numbers. Please note that **only the devices listed below are affected. No other Boston Scientific product is involved in this Field Safety Notice.**

Further distribution or use of any remaining product affected by this action should cease immediately.
