Dear Customer,

This letter is to inform you that Kimal Plc has received an urgent medical device recall notice from our supplier, AngioDynamics. The manufacturer of Vaxcel PICC with PASV, Xcela PICC triple lumen with PASV and Bioflo PICC triple lumen with Endexo and PASV is conducting a medical device recall on specific lots of these devices.

AngioDynamics is conducting a medical device recall on PICC catheters that contain valve(s) manufactured prior to July 15, 2014. Valves manufactured after this date incorporate a manufacturing specification change that reduces the incidence of haemolysis during blood sampling through the catheter. Use of the PICC catheters that are subject to this recall may result in an increased incidence of haemolysed blood samples which may require additional peripheral access or replacement of the PICC catheter.

Description of issue:

Kimal's supplier, AngioDynamics is conducting a medical device recall on PICC catheters that contain valve(s) manufactured prior to July 15, 2014. Valves manufactured after this date incorporate a manufacturing specification change that reduces the incidence of haemolysis during blood sampling through the catheter. Use of the PICC catheters that are subject to this recall may result in an increased incidence of haemolysed blood samples which may require additional peripheral access or replacement of the PICC catheter.

Action to be taken by the user:

- Please check your stock for the specified product code(s) and lot number(s) of PICC catheters.
- Please discontinue use, isolate, label and quarantine any stock to prevent continued use.
- Complete Appendix 1 of the Field Safety Notice and return to the contact reference person at Kimal, with quantities where replacements are required.
- Kimal will arrange for an alternative replacement product meeting the correct specification, or credit for your returned product.

Since this issue became known, appropriate measures have been introduced to prevent recurrence. We apologise for the inconvenience caused by this action, taken to safeguard your patients and users.
