

URGENT FIELD SAFETY NOTICE

1-DAY ACUVUE® MOIST® (etafilcon A) Brand Contact Lenses.

Action: Voluntary and limited recall of lots 2054890521, 2054895620 and B00DJPQ.

Dear Eye Care Professional:

The purpose of this communication is to inform you that Johnson & Johnson Vision Care, part of Johnson & Johnson Medical Ltd, is voluntarily recalling boxes from 2 lots of 1-DAY ACUVUE® MOIST® Brand Contact Lenses and 1 lot of ACUVUE® ADVANCE® Brand Contact Lenses with HYDRACLEAR®

This letter provides important information concerning this Field Action as our shipping records show that you are one of our customers that have received the affected lots. MHRA and our notified body, BSi, have been informed of this action. This voluntary action is only for those products with the affected lot numbers listed on the package (see below for more information). 1-DAY ACUVUE® MOIST® and ACUVUE® ADVANCE® contact lenses without the affected lot numbers can continue to be used, and no other products in the ACUVUE® family are affected. Please share this information with your staff so that we may work together to retrieve and replace all 1-DAY ACUVUE® MOIST® and ACUVUE® ADVANCE® product affected by this recall.

Details of Field Action:

This action is being initiated as a precautionary measure following an internal quality review in which we discovered the potential for a limited number of contact lens packages to not have completely sealed. An incomplete seal may result in the loss of or leaking of the packaging solution in some individual contact lens units. Since an incomplete seal could possibly compromise contact lens sterility, an eye infection is a potential health risk associated with this occurrence. However, the chances of this occurring are remote. No adverse events have been reported to date. The cause has been identified and rectified.

Within the lots being recalled, it is estimated that about 0.25% (approximately 20 lenses) could potentially be affected. In some instances a user might open the individual contact lens package and see little or no solution inside the packaging and a lens that is dried out and unusable. In other situations, the incomplete seal and its effect on the package and the lens will not be noticeable to the user. However, regardless of the visible condition of the lens or the individual contact lens package, it is important to return all lenses in the affected lots in accordance with the instructions below. The company is initiating this voluntary recall as a precaution so that wearers will continue to experience the performance and quality they expect from ACUVUE® Brand Contact Lenses.
